

Visa FIFA World Cup Qatar 2022 Campaign: 7th September– 30th October 2022 - Nigeria

Mechanics and Campaign Overview:

Visa Card holders are to spend a minimum of NGN50,000 (Fifty Thousand Naira) or \$1,000 (One thousand US Dollars) using their Visa Card or Visa QR online or POS in at least 5 transactions and stand a chance to win a trip to Qatar and other consolation Prizes.

This promotion will be on a “first come first served” basis. The first 3 winners to meet the spend threshold in the month of September will be rewarded with the Trip to Qatar Packages while the consolation prizes will be available to the first 20(twenty) Visa Cards in the month of October. The prizes will be split equally between Naira and USD Cards). Eligibility for the Visa Card shall be drawn from cards used in the following transaction categories:

Terms and Conditions:

1. Disclaimer

This Campaign is operated by Visa and not by the financial institution that issued the Visa card to you. As you are aware, Visa is not a card issuer and does not provide credit, debit or any financial services. Any issues you may have with respect to your card should be directed to your issuer and not to Visa. The relationship between Visa and your card issuer does not create any relationship direct or indirect between the cardholder and Visa. 2. Duration

- All Visa cards and payment credentials are eligible for the campaign i.e. Debit, Prepaid, Credit, Virtual cards and Visa QR.
- Visa takes no responsibility for any inaccurate reporting or non-visibility of qualifying transaction either by collections only files or non-accessibility.
- Winner should inform the bank of his/her acceptance or rejection of the prize within 24 hours.
- The winner is responsible for obtaining their travel visa from the embassy of Qatar. If unable to accept the prize, the bank is to make the offer to the next Eligible Visa Card.
